### **Applications for Refunds or Benefits:**

1. Karen Hobbs has applied for Survivor's benefits after the death of her husband James Hobbs on June 26, 2021. Jim was currently on retirement benefits at the time of his death. She enclosed the proper paperwork including a signed application, certificate of marriage and the certificate of death as required. Since Jim was currently receiving a regular retirement benefit, she is entitled to his current benefit without any cost of living increases as laid out in the statute.

**Motion**: To award Karen Hobbs a survivors benefit effective June 27, 2021. She will receive a partial payment of \$824.83 for the month of June and a monthly payment of \$6,186.25 from July, 2021 forward. Lauterbach and Amen confirmed calculations of her benefit.
