**ANNUAL TAX LEVY ORDINANCE FOR
DARIEN-WOODRIDGE FIRE PROTECTION DISTRICT**

**AN ORDINANCE FOR THE LEVY, ASSESSMENT AND COLLECTION OF TAXES FOR
THE DARIEN-WOODRIDGE FIRE PROTECTION DISTRICT, DU PAGE COUNTY, ILLINOIS,
FOR THE ENSUING FISCAL YEAR BEGINNING JUNE 1, 2020, AND ENDING MAY 31, 2021**

BE IT ORDAINED BY THE BOARD OF TRUSTEES OF THE DARIEN-WOODRIDGE FIRE PROTECTION DISTRICT, DU PAGE COUNTY, ILLINOIS;

The amount of taxes for the present current fiscal year beginning June 1, 2020, and ending May 31, 2021, for all corporate purposes, inclusive of the sums, if any, necessary to retire general corporate bonds and bonded indebtedness of the Darien-Woodridge Fire Protection District, and interest thereon, and the interest upon unmatured bonds to be levied on all property of the Darien-Woodridge Fire Protection District, including railroads, are assessed and equalized for State and County purposes for the year, be and the same are hereby fixed at Seven Million, Six Hundred Three Thousand, One Hundred Fifty and 00/100 Dollars (\$7,603,150.00) the same is hereby accordingly levied upon all property in the Darien-Woodridge Fire Protection District, DuPage County, Illinois, subject to taxation.

The same sum of Seven Million, Six Hundred Three Thousand, One Hundred Fifty and 00/100 Dollars (\$7,603,150.00) being taxes to be levied for the fiscal year as described in Sections I, II and III of the Ordinance shall, when received, be used for the purpose of paying the items for which an appropriation has heretofore been made in the Combined Annual Budget and Appropriation Ordinance passed by the President and Board of Trustees of the Darien-Woodridge Fire Protection District on the 19th day of August, 2020, and published by order of the Secretary of the Darien-Woodridge Fire Protection District, DuPage County, Illinois, on the 2nd day of September, 2020, in the DuPage County Chronicle, a secular newspaper of general circulation, that has been regularly published and circulated in the District for more than six months prior to the date of publication of the Ordinance, as required by law, as will more fully appear from the certificate endorsed upon the original Ordinance now on file in the office of the Secretary of the Darien-Woodridge Fire Protection District.

SECTION I - GENERAL CORPORATE FUND

The following sums, or so much thereof as may be authorized by law, having been appropriated, are to be levied for the Corporate purposes of the Darien-Woodridge Fire Protection District, DuPage County, Illinois, as set forth for the fiscal year beginning on the first day of June, 2020, and ending on the thirty-first day of May, 2021:

SECTION II - PENSION, INSURANCE AND OTHER SPECIAL FUNDS

The following sums, or so much thereof as may be authorized by law, having been appropriated are to be levied for Pension, Insurance and Other Special purposes of the Darien-Woodridge Fire Protection District, DuPage County, Illinois, as set forth for the fiscal year beginning on the first day of June, 2020, and ending on the thirty-first day of May, 2021:

E.	For Illinois Municipal Retirement Fund	15,000.00
F.	For unemployment compensation (745 ILCS 10/9-103, 10/9-107).....	3,700.00
G.	For tort liability and risk management program (745 ILCS 10/9-103, 10/9-107, 745 ILCS 10/9-107).....	1,468,000.00


SECTION IV

This Ordinance shall be in full force effect from and after its passage and approval as required by law.


