

ORDINANCE NO. 22-O-1

AMENDED APPROPRIATION ORDINANCE
FOR DARIEN-WOODRIDGE FIRE PROTECTION DISTRICT,
DU PAGE COUNTY, ILLINOIS

WHEREAS, the Darien-Woodridge Fire Protection District, DuPage County, Illinois, an Illinois municipal corporation, approved and adopted its Combined Annual Budget and Appropriation Ordinance, No. 21-O-3 on August 18, 2021; and

WHEREAS, new and additional information has come to the District's attention regarding the District's obligation for payments to the Firefighter's Pension Fund and for auditing; and

WHEREAS, it is necessary to authorize and approve these additional expenditures for the District to meet its obligations.

NOW, THEREFORE, BE IT ORDAINED BY THE BOARD OF TRUSTEES OF THE DARIEN-WOODRIDGE FIRE PROTECTION DISTRICT, DU PAGE COUNTY, ILLINOIS AS FOLLOWS:

1. The Preambles as set forth above are incorporated herein by reference.
2. Section II of the Combined Annual Budget and Appropriation Ordinance, No. 21-O-3, appropriating sums for Pension, Insurance and Other Special Purposes of the Darien-Woodridge Fire Protection District, DuPage County, Illinois, for the fiscal year beginning on the first day of June, 2021 and ending on the thirty-first day of May, 2022 is deleted and replaced with the following:

A.	For auditing (50 ILCS 310/9).....	\$ 17,500.00
B.	For social security and payroll taxes	100,000.00
C.	For Firefighter's Pension Fund (40 ILCS 5/4-118).....	1,414,500.00
D.	For Firefighter's Pension Fund exempt from "tax cap" limitation (40 ILCS 5/4-118).....	141,450.00
E.	For Illinois Municipal Retirement Fund	50,000.00
F.	For workers' compensation insurance premiums (745 ILCS 10/9-103, 10/9-107).....	200,000.00
G.	For unemployment compensation (745 ILCS 10/9-103, 10/9-107).....	8,000.00
H.	For tort liability and risk management program (745 ILCS 10/9-103, 10/9-107, 745 ILCS 10/9-107).....	1,000,000.00
