ORDINANCE NO. 21-O-1

AMENDED APPROPRIATION ORDINANCE FOR DARIEN-WOODRIDGE FIRE PROTECTION DISTRICT, DU PAGE COUNTY, ILLINOIS

WHEREAS, the Darien Woodridge Fire Protection District, DuPage County, Illinois, adopted and approved its Combined Annual Budget and Appropriation Ordinance, No. 20-O-1 on August 19, 2020; and

WHEREAS, in November 2020, a Bond Referendum was approved by the voters of the Darien Woodridge Fire Protection District. This resulted in the District receiving proceeds from the sale of those Bonds of \$8,200,995.35 out of which expenditures are to be made which were not provided for when the Combined Annual Budger and Appropriation Ordinance was approved; and

WHEREAS, it is necessary to authorize and approve these additional expenditures of some of the proceeds from the Bond Referendum.

NOW, THEREFORE, BE IT ORDAINED BY THE BOARD OF TRUSTEES OF THE DARIEN-WOODRIDGE FIRE PROTECTION DISTRICT, DU PAGE COUNTY, ILLINOIS AS FOLLOWS:

- 1. The Preambles as set forth above are incorporated herein by reference.
- 2. The following sums are additionally appropriated for corporate and ambulance and paramedic purposes of the Darien Woodridge Fire Protection District, DuPage County, Illinois, as herein specified and set forth for the fiscal year beginning on the first day of June, 2020 and ending on the thirty-first day of May, 2021:
