Chief Lahanis would like to run the test in January, 2025. Both Battalion Chief and Lieutenant tests need to be updated.

Chair Report

Chair Cryer led review of the new swearing-in process. All agreed that conducting ceremony at Trustee meeting is best. Consensus of group that the Chief should read the statement at the probation swearing-in. If new hire needs to start before a trustee meeting, Chief could swear in informally. New hire could then be introduced at following Trustee meeting.

Chair Cryer led discussion of candidate interview questions. He directed Commissioners to review the swearing in ceremony and the Rules and Regulations before next meeting. He and Chief Lahanis will further review interview questions.
