Chief Administrator's Report:

Chief Lahanis provided an overview of department activities.

- A few members welcomed babies during the months of June and early July.
- The City of Darien and the Village of Woodridge are both still exploring possible TIF districts. The Village of Woodridge is holding a public meeting on July 17th to discuss the proposed 75th Street Corridor TIF District.
- The new District website is active and is easier to navigate as well as ADA compliant.
- An executive summary of the 2025 Strategic Plan includes a clear and mission driven framework to assist the District with future goals.
- The DuPage ETSB will be distributing new portable radios by the end of August. An IGA will need to be entered into to ensure the radios are being used as outlined by the law.

Deputy Chief's Report:

Deputy Chief Tunk was not in attendance and Chief Lahanis provided an overview of department responses and activities.

- Emergency response calls continue to trend upwards by approximately 4% over the previous year.
- Staff are awaiting decision on several submitted grant requests.

Board of Fire Commissioners Report:

Commissioner Cryer advised the BC testing process has concluded with two candidates on the final promotional list. Promotions are planned for early September, and hiring will all take place late September.
