Attorney Nichele advised a Local Government Efficiency Act was signed into law by Illinois Governor J.B. Pritzker. The Act requires all units of local government that may levy a tax, except municipalities and counties, to convene a committee to "study local efficiencies and report recommendations regarding efficiencies and increased accountability." The committee will consist of trustees, fire chief and two fire district residents. Three meetings will be held within 18 months and a report will be compiled upon completion. The committee must be formed by June 23, 2023.
