After vendor and specification review and discussions, the Ladder Committee felt Pierce Manufacturing through MacQueen best met the Darien-Woodridge Fire District's needs.

Firefighters Darrell Parrish and Andy Chearo presented an overview on specifications for the proposed new ladder truck. After discussion direction was given to obtain a written contract from MacQueen to be presented at the January 2025 meeting for further review and consideration.
